If possible, use a separate form for each owner. **On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after its name.** \* The Kennel Club Authority to Compete number (for dogs registered and resident outside the UK) must be stated or the entry will be returned **ON NO ACCOUNT WILL ENTRIES BE ACCEPTED WITHOUT FEES**
